1. The Exhibitor agrees to rent space at a specified rate.

2. The space rental fee specified in contract must be received by **MAY 28, 2017**
3. The Exhibitor to provide a copy of insurance certificate showing \$1,000,000 Liability.  
The Exhibitor is responsible for its own multi-peril insurance to protect itself, its employees, and its display at the Fair and the Exhibitor agrees to reimburse the Fair for any amounts paid out and cost incurred by the Fair as a result of any Liability claim for which the Exhibitor is responsible.
